In a bush, they found a firearm that had been wrapped in a t-shirt. Witnesses identified the suspect, charging him with Firearms Restrictions-Weapons on School Grounds, Domestic Violence 3rd Degree (Harassment), Menacing and Tampering with Physical Evidence.
